## **MISSIONS EVANGELISM TRAILER (M.E.T.) USAGE GUIDELINES**

1. Member Churches of SJRBA will be given priority in using the MET.
2. The MET may be used by Southern Baptist Churches or Southern Baptist Associations outside of SJRBA.
3. The MET must be reserved in advanced by calling the SJRBA Office.
4. The MET must be signed in and out through the SJRBA Offices.
5. A signed Notarized waiver must be on file with SJRBA.
6. **There is a \$75 maintenance fee. The use of the MET may not exceed 7 days.**
7. When in use all equipment in the MET must be supervised by an adult.
8. Clean all equipment after each use. The MET is not self-cleaning.
9. Be considerate of others and promptly return the MET to the SJRBA Office.
10. Beginning in 2017, each Church must have persons properly trained by SJRBA in the use of the MET.
11. Children must remove theirs shoes when playing on the Velcro Wall/bounce house.
12. Velcro Wall and Bounce House should ***not*** be placed on asphalt/concrete surfaces.
13. Report any faulty or broken equipment to the SJRBA Office. The Church will be responsible for any damage of the equipment that occurs while in your possession.
14. Each Church is responsible for furnishing supplies for the use of the Sno-Cone and/or popcorn Machine.
15. Please be sure to use the proper blower with each blowup. The blue blower is to be used for the Velcro Wall. The green blower is to be used for the Bounce House.
16. Do not use 2 blowers on 1 unit. Use 2 different circuits; one for each blow-up.
17. Please make sure both inflatables are ***dry*** before folding them up. You may use the leaf blower to assist in drying the inflatables before loading the inflatables inside the MET.

We trust the use of this MET has been and will continue to be a great witnessing tool for you as you reach out into your community for the cause of Christ. We are pleased that you chose to partner with SJRBA. May God Bless each of you as you continue to minister to others and see many people commit their lives to Christ and accept them as their personal Lord and Savior.
